*Additional visit fees apply to students who request a workplace visit, or to Trainees who request visits in addition to those provided as part of their traineeship. Traineeship fees are indicative and based on a total of 4 required visits. This may be reduced through RPL or credit transfer arrangements and will be charged on a pro rata basis if fewer visits are required.

Regional locations are determined based on the 'Regional Postcodes Report' published by the Department of Education and Training. Metro fees apply for Traineeship students within 50 kms of Swan Hill.
